Procedure Change:

If you are the first reader when the children are leaving for the Children's Liturgy, remain in your seat until the music has stopped, then proceed to the ambo and begin reading as you normally would.

If you are unable to serve on a day for which you are scheduled, please, obtain a substitute. If you cannot serve on a certain day in March or April, please, contact me no later than **February 10th**. You may use the Resurrection web site (resurrectionwg.org) to look at the schedule and to make requests.

Some of you may have trouble finding a substitute to read for you. If that is the case, you should call readers from other Masses to cover for you.

Reminder #1 – Pause before saying, “The Word of the Lord” and speak those words slowly and deliberately.

Reminder #2 – As you begin your proclamation with “A Reading from...”, the A is pronounced as a short a, like *uh*, not the long *a*.
